THIS AGREEMENT, made this 13th day of September, 2017 between the MUNICIPALITY OF MANGALDAN, represented by the Municipal Mayor, **HON. BONAFE DE VERA-PARAYNO**, of legal age, Filipino citizen, married and a resident OF Poblacion ,, Mangaldan, Pangasinan (hereinafter called the "Entity") and **GOLDEN VISION CONSTRUCTION AND SUPPLY**, represented by its proprietor . **MS. EVANGELINE S. DORIA**, of legal age, Filipino citizen, a resident of #85 Magsaysay Avenue, Poblacion Basista, Pangasinan (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Core Local Access Road (Rehabilitation of Embarcadero-Nibaliw Road) Located at Barangay Embarcadero Mangaldan, Pangasinan-Labor & Materials* is chargeable against ADM 2017 Trust Fund for the Municipality of Mangaldan (hereinafter called "the Works") and the Entity has accepted the bid of ONE MILLION FIVE HUNDRED NINETY NINE THOUSAND THREE HUNDRED THIRTY PESOS AND 02/100 (PHP 1,599,330.02), by the Contractor for the Execution and completion of such contract and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached; deemed to form, and be read and construed as part of this Agreement, to wit:

- (a) General and Special Conditions of Contract;
 - (b) Specifications;
 - (c) Invitation to Apply for Eligibility and to Bid;
 - (d) Instructions to Bidders;
 - (e) Bid Data Sheet;
 - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Credit line issued by a licensed bank, if any;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (R) Other contract documents that may be required by existing laws and/or the Entity.

In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, *Core Local Access Road (Rehabilitation of Embarcadero-Nibaliw Road) Located at Barangay Embarcadero Mangaldan, Pangasinan-Labor & Materials*, the Contractor hereby covenants with the Entity to execute and complete the delivery of said be charged against ADM 2017 Trust Fund.


3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, *Core Local Access Road (Rehabilitation of Embarcadero-Nibaliw Road) Located at Barangay Embarcadero Mangaldan, Pangasinan-Labor & Materials* the Contractor hereby covenants with the Entity to execute and complete the delivery of said project and remedy any defects therein in conformity with the provisions of this Contract and all respects.

4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Contract and the remedying of defect wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

5. That the CONTRACTOR shall deliver and turn over the same *Core Local Access Road (Rehabilitation of Embarcadero-Nibaliw Road) Located at Barangay Embarcadero Mangaldan, Pangasinan-Labor & Materials* to the OWNER within SEVENTY FIVE (75) calendar days without any further extension, provided, however, that the proper inspection shall have been conducted by the Office of the Municipal Engineer; and that the payment of the cost of *Core Local Access Road (Rehabilitation of Embarcadero-Nibaliw Road) Located at Barangay Embarcadero Mangaldan, Pangasinan-Labor & Materials* is chargeable against ADM 2017 Trust Fund.
