

Contract Agreement

THIS AGREEMENT, made this 9th day of December, 2019 between the MUNICIPALITY OF MANGALDAN, represented by the Municipal Mayor, **MARY MARILYN DG. LAMBINO**, of legal age, Filipino citizen, married and a resident of Buenlag, Mangaldan, Pangasinan (hereinafter called the "Entity") and **EXTENSIVE STEEL WORK AND CONSTRUCTION**, represented by its proprietor **Antonio W. Ollado**, of legal age, Filipino citizen, married and a resident of Lingayen, Pangasinan (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the supplier execute Local Access Road Rehabilitation/Improvement in Barangay Poblacion to Guilig (Jimenez Street) Mangaldan is chargeable against Trust Fund for the Municipality of Mangaldan, Pangasinan (hereinafter called "the Works") and the Entity has accepted the bid of EIGHT MILLION THREE HUNDRED TWENTY FOUR THOUSAND FIVE HUNDRED TWENTY NINE PESOS 63/100 (PHP 8,324,529.63) by the Contractor for the Execution and completion of such contract and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:



1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Specifications;
 - (c) Invitation to Apply for Eligibility and to Bid;
 - (d) Instructions to Bidders;
 - (e) Bid Data Sheet;
 - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Credit line issued by a licensed bank, if any;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (R) Other contract documents that may be required by existing laws and/or the Entity.

In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, *Local Access Road Rehabilitation/ Improvement in Barangay Poblacion to Guilig (Jimenez Street) Mangaldan, Pangasinan* the Contractor hereby covenants with the Entity to execute and complete the delivery of said be charged against Trust Fund.

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, *Local Access Road Rehabilitation/ Improvement in Barangay Poblacion to Guilig (Jimenez Street) Mangaldan, Pangasinan*, the Contractor hereby covenants with the Entity to execute and complete the delivery of said-project and remedy any defects therein in conformity with the provisions of this Contract and all respects.

4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Contract and the remedying of defect wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

5. That the CONTRACTOR shall deliver and turn over the same *Local Access Road Rehabilitation/ Improvement in Barangay Poblacion to Guilig (Jimenez Street) Mangaldan, Pangasinan* to the OWNER within One Hundred Twenty days (120) calendar days without any further extension, provided, however, that the proper inspection shall have been conducted by the Office of the Municipal Engineer; and that the payment of the cost of the *Local Access Road Rehabilitation/ Improvement in Barangay Poblacion to Guilig (Jimenez Street) Mangaldan, Pangasinan* is chargeable against Trust Fund.






