EXECUTIVE ORDER NO. 01, Series of 2019

“CREATING THE MUNICIPAL PERFORMANCE CHALLENGE FUND (PCF) PROJECT IMPLEMENTATION AND MANAGEMENT TEAM OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”

WHEREAS, the local government unit of Mangaldan, Pangasinan has been conferred with the Seal of Good Local Governance (SGLG) being implemented by the Department of the Interior and Local Government (DILG) recognizing the LGUs exemplary performance in the governance areas of development planning, sound fiscal management, transparency and accountability and valuing performance management;

WHEREAS, the local government of Mangaldan, Pangasinan as a SGLG awardee, is entitled to access and receive the Performance Challenge Fund amounting to **THREE MILLION PESOS TWO HUNDRED THOUSAND (Php 3,200,000.00)**;

WHEREAS, *DILG Memorandum Circular No. 2018-203 dated November 16, 2018* requires the creation of an LGU PCF Project Implementation and Management Team to facilitate project implementation and monitoring;

NOW, THEREFORE, I, BONA FE DE VERA-PARAYNO, Municipal Mayor of Mangaldan, Pangasinan, by virtue of the powers vested in me by law, do hereby organize and mobilize the PCF Project Implementation and Management Team of Mangaldan, Pangasinan.

Section 2. FUNCTIONS

1. Facilitate the preparation and submission of all documentary requirements for the release of the Performance Challenge Fund;
2. Monitor the progress and oversee the implementation of the PCF funded projects;
3. Facilitate the preparation and submission to the DILG Regional office quarterly progress reports of physical accomplishment and fund utilization, and report of disbursements verified by the Local COA;
4. Upon completion of the project, facilitate the preparation and submission to DILG Regional Office project completion report;
5. Performs such other functions related to PCF implementation and management as may be prescribed by competent authorities.

Section 3. EFFECTIVITY

This order shall take effect immediately.
