Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183. b. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184. 3. Prospective Bidders may obtain further information from Municipal Government of Mangaldan,Pangasinan and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M,BAC Office. 4. The Procuring Entity shall allow the bidder to present its proof of payment for the fees. 5. The Municipal Government of Mangaldan,Pangasinan will hold a Pre-Bid Conference on N/A at BAC Office, 1st Floor, Beside Engineering Office, which shall be open to prospective bidders. 6. Bids must be in a yellow envelope and duly received by the BAC Secretariat through manual submission at the office address indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before 9:00 A.M., May 22, 2024. Late bids shall not be accepted.
