REHABILITATION/ IMPROVEMENT OF MANGALDAN PUBLIC MARKET OF LGU-MANGALDAN, PANGASINAN The Municipal Government of Mangaldan, Pangasinan, through the Municipal Budget of Mangaldan, Pangasinan intends to apply the lump sum of One Million Seven Hundred Fifty Thousand Pesos (Php 1,750,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for REHABILITATION/ IMPROVEMENT OF MANGALDAN PUBLIC MARKET OF LGU-MANGALDAN, PANGASINAN with Identification Number: MMP-PB-2024-060 Lump Bids received in excess of the ABC shall be automatically rejected at bid opening provided that each project does not exceed the project cost as follows;

- 1. The Municipal Government of Mangaldan, Pangasinan, now invites bids for the above Procurement Project. Completion of the Works is required (45) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 2. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 3. Interested bidders may obtain further information from Municipal Government of Mangaldan, Pangasinan inspect the Bidding Documents at the address given below from 8:00 A.M. to 4:00 P.M. except Holidays.
- 4. A complete set of Bidding Documents may be acquired by interested bidders on October 1, 2024 to October 21, 2024 from given address and website/s below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 5. The Municipal Government of Mangaldan, Pangasinan will hold a Pre-Bid Conference on 10:00 A.M., October 9, 2024 at BAC Office, 1st Floor, Beside Engineering Office which shall be open to prospective bidders.
- 6. Bids must be inside a red envelope and duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before 9:00 A.M., October 21, 2024. Late bids shall not be accepted.
- 7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 8. Bid opening shall be on 2:00 P.M., October 21, 2024 at the BAC Office, 1st Floor, Beside Engineering Office. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 9. The Bidding process applies the GBPB Resolution No.14-2019 dated July 17, 2019 and GPPB Circular No. 06-2019 dated July 17, 2021 on Early Procurement Activities (EPA), wherein, the Award of Contract shall be made after the Final Approval of the Loan from the Land Bank of the Philippines.

10. The Municipal Government of Mangaldan, Pangasinan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
