Bids received in excess of the ABC shall be automatically rejected at bid opening provided that each project does not exceed the project cost as follows;  1. The Municipal Government of Mangaldan,Pangasinan now invites bids for the above Procurement Project. Delivery of the Goods is required by (15) Calendar Days. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.  b. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.  3. Prospective Bidders may obtain further information from Municipal Government of Mangaldan,Pangasinan and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M,BAC Office.  4. The Municipal Government of Mangaldan,Pangasinan will hold a Pre-Bid Conference on 10:00 A.M., October 30, 2024, at the BAC Office, 1st Floor, Beside the Engineering Office, which shall be open to prospective bidders.  6. Bids must be in a yellow envelope and duly received by the BAC Secretariat through manual submission at the office address indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before 9:00 A.M., November 11, 2024. Late bids shall not be accepted.
