GUEGUESANGEN, MANGALDAN, PANGASINAN with Identification Number: MMP-PB-2025-004 Lump Bids received in excess of the ABC shall be automatically rejected at bid opening provided that each project does not exceed the project cost as follows; 1. The Bidding process applies the GBPB Resolution No.14-2019 dated July 17, 2019 and GPPB Circular No. 06-2019 dated July 17, 2021 on Early Procurement Activities (EPA), wherein, the Award of Contract shall be made after the Final Approval of the Loan from the Land Bank of the Philippines. 10.
