8. Bid opening shall be on 10:00 A.M., July 18, 2023 at the Residencia Municipal, 2nd Floor, Conference Room. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.								
9. The Bidding process applies the GBPB Resolution No.14-2019 dated July 17, 2019 and GPPB Circular No. 06-2019 dated July 17, 2021 on Early Procurement Activities (EPA), wherein, the Award of Contract shall be made after the Final Approval of the Loan from the Land Bank of the Philippines.
