Bids must be inside a red envelope and duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before 9:00 A.M., February 28, 2024. Late bids shall not be accepted. 7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16. 8. Bid opening shall be on 10:00 A.M., February 28, 2024 at the BAC Office, 1st Floor, Beside Engineering Office. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity. 9. The Bidding process applies the GPPB Resolution No.14-2019 dated July 17, 2019 and GPPB Circular No. 06-2019 dated July 17, 2021 on Early Procurement Activities (EPA), wherein, the Award of Contract shall be made after the

Final Approval of the Loan from the Land Bank of the Philippines.
