Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.</p> <p>a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.</p> <p>b. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.</p> <p>3. Prospective Bidders may obtain further information from Municipal Government of Mangaldan,Pangasinan and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M,BAC Office.</p> <p>4. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.</p> <p>5. The Municipal Government of Mangaldan,Pangasinan will hold a Pre-Bid Conference on 10:00 A.M., March 13, 2024 at BAC Office, 1st Floor, Beside Engineering Office, which shall be open to prospective bidders.</p> <p>6. Bids must be in a yellow envelope and duly received by the BAC Secretariat through manual submission at the office address indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before 9:00 A.M., March 25, 2024. Late bids shall not be accepted.</p>

7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

8. Bid opening shall be on 2:00 P.M., March 25, 2024 at the given address below BAC Office, 1st Floor, Beside Engineering Office; Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
